The above named group agrees to the following terms and conditions:

1. A nonrefundable deposit of \$200 and a \$100 refundable cleaning/damage deposit must be received one month prior to arrival date.
2. Abide by all camp rules and regulations.
3. Conduct all activities at camp in accordance with the mission and purpose of Pine Springs Camp and Retreat Center.
4. Notify the camp of any behavior which is dangerous or outside of the mission of Pine Springs Camp and Retreat center.
5. Allow no use of alcohol or tobacco on the camp premises.
6. Receive approval for camp fires with the camp facilities manager.
7. Keep all buildings and facilities clean and orderly.
8. Prevent destruction and disruption of trees, plants, and all natural growth on camp property.
9. Dispose of trash as directed by the camp facilities manager.
10. Assume responsibility for damage or injury to the group's participants, the property, and structures arising from the group's use of the facilities or activities organized by the above named group.

11. **RELEASE AND FOREVER DISCHARGE** Lubbock Christian University and Pine Springs Camp, its components, sponsors, agents, employees, officers, trustees and affiliates of Lubbock Christian University ("LCU") and Pine Springs Camp, of and from any and all liability to the group, the groups assigns, heirs and next of kin, from any and all claims, demands, controversies, actions or causes of action, belonging the above named group now or in the future for any damage to or loss of group's property, and any injury to groups participants including death or any one or more of the foregoing, arising directly or indirectly out of the group's use of the camp facilities, including any damage, loss or injury caused by any act or omission on the part of LCU, including any negligent conduct of LCU but excluding any gross negligence or willful misconduct of LCU or Pine Springs Camp. The above release includes the release of LCU from the consequences of LCU's own negligence. The only circumstance under which the release of LCU or Pine Springs Camp does not apply is with respect to any occurrence resulting from the gross negligence or willful misconduct of LCU or Pine Springs Camp.

The above named group understands and confirms:

1. Insurance will not be provided by Pine Springs Camp or Lubbock Christian University. **All non-LCU groups must submit proof of insurance with this contract.**
2. Pine Springs Camp and Retreat Center reserves the right to request any group member or group to leave at anytime without a return of deposit or payment.

4. All payment is due at the time of arrival in accordance with the rates as shown below.

Camp Rates (Please circle one.)

Option 1—All Inclusive: Camp personnel will organize meals and cook for each member of the group. This rate includes use of all facilities, accommodations for each member of the group and three meals daily.
\$40 per person per day (children two and under are free).

Option 2—Partial Rates: The group will be responsible for some or all meals. Groups will notify camp to what meals need to be prepared by camp personnel.

Lodging: \$20 per person per night Breakfast: \$6 per person
Lunch: \$7 per person Dinner: \$7 per person

Children 5 years and younger are free. Children 6-10 years of age are half-price.

Option 3 – Cook your own meals: \$20 per person per night lodging.
